Thursday, February 26 9:30 A.M. to 3:00 P.M.

The intent of the Mesa County Safety Fair is to promote safety messages to elementary school students. The selling or promoting of products or services is discouraged. The Mesa County Safety Council Board of Directors reserve the right to approve applications.

We hope you are able to join us at the 2026 safety fair. Your participation helps make our community a safer place for everyone. We anticipate 1200-1300 students from public, private, and homeschools mainly in second, third, and fourth grades to attend the in-person safety fair. Groups of students will be provided bussing to the fair at different times throughout each day.
